## 4k video songs 2019

If you have an iPhone 6 or later, you can change the speed and resolution with which your phone captures recorded video and slow video. If you prefer to use less memory and really only watch on videos on your phone, a lower resolution can help you save space. If you want to capture a higher resolution (such as 4K) or smoother video (like 60fps), bumping into a setting that costs some storage space but may be worth it for you. You really only have two options here, and bumping into videos up to 1080p by default 720p comes with a significant price to frame rate. While the resulting video will look sharper, you will lose a bit of smoothness. Play with two options and see what looks best for you based on what types of items you shoot.
